## HOW TO ORDER YOUR PASS



1. Go To <https://exhibitors.enercarecentre.com/exhibitorforms/>
2. Select Your Show/Event, Enter Your Booth Number, Agree to Terms/Privacy policy, and Login
3. Enter Company Information, Click Save
4. Click Parking Passes, Indicate quantity beside pass type, Click Add/Change Order
5. Click Review Order, Ensure order is correct then Submit Order
6. Input Payment information and Submit
7. Print order confirmation that was emailed to you for pass pick-up

## FREQUENTLY ASKED QUESTIONS



1. **How many passes can I order?**  
You can purchase as many Exhibitor Parking Passes as required to successfully run your operation, there is no limit.
2. **What are my payment options?**  
We accept, Master Card, Visa, and American Express. **Visa Debit is NOT Accepted.**
3. **Where do I pick-up my pass?**  
The location for picking up exhibitor parking passes is normally the Exhibitor Services office next to Salon 106, however this location is subject to change based on your show location.

## TERMS & CONDITIONS

1. All Exhibitors must park in the designated lot assigned by Parking Services (lots are subject to changes).
2. Lost, Stolen and Damaged parking passes will be replaced at the on-site price.
3. All Exhibitor Parking Passes are non-transferable from the individual vehicle that the Pass was issued to.
4. No service will be provided without payment in full. NO EXCEPTIONS.
5. No orders will be processed after the deadline. No multi-day passes available for purchase on-site, must pay daily. NO EXCEPTIONS
6. During move-in/out, exhibitor parking is available at no additional charge at designated lots only (and subject to availability).
7. Exhibitor Parking Pass must be displayed "Face Up" on the dashboard or "Hanging" from rearview mirror of vehicle as proof of payment whenever the vehicle is parked in Exhibition Place parking lots. Failure to meet these requirements will be subject to tag and tow bylaws.
8. Exhibition Place is not responsible for theft, loss or damage to vehicle or contents while parked on any Exhibition Place property. Charges are for use of parking space only. Vehicles are parked at owner's risk.
9. Only authorized parking is permitted on Exhibition Place property. Unauthorized vehicles are subject to tag and tow bylaws.
10. Exhibition Place reserves the right to revoke any Exhibitor Parking Pass at its discretion.
11. Exhibition Place reserves the right to alter the designated lots.
12. Exhibitors will be held responsible for any/all damages to parking control equipment and/or parking infrastructures or electrical equipment caused by themselves or their vehicle.
13. Bus/Truck/Trailer or Camper RV parking is not permitted without authorization by Parking Services.
14. No overnight parking is permitted without prior authorization from Parking Services.
15. Rates quoted include all applicable taxes (HST).
16. Cancellation of orders can be refunded less a \$15.00 administration fee.
17. Passes can be picked up at Exhibitor Services during show/event move-in according to set hours of operation. **(Passes will not be mailed out)**
18. Payment in Canadian funds at time of order. Accepted payment is credit card only (Visa-Debit Not accepted). Cheques, cash, or Debit will not be accepted.
